She reported that BVRA and the Union County Trail Authority has not completed the transfer of the Buffalo Valley Rail Trail to date, but the legal process is proceeding, and transfer is estimated to be April 1. There has been no update on the BVRA request for funds from the Union County Trail Authority. She noted she would look into Vice Chairman Rowe's question regarding a written funding agreement will ask at the next meeting about the agreement with the Lewisburg Borough, especially in light of the EBT agreement clause which has BVRA accepting the term of disallowing reduced program fees for residents from municipalities that do not have a written funding agreement with the Authority. The next BVRA meeting is scheduled for Wednesday, February 27, 2019 at 5:00 PM.

Supervisor Schumacher reported that the next Buffalo Valley Regional Police meeting is scheduled for February 13, 2019 at 5:00 PM. He also reported that Central Susquehanna Fire and Emergency Services Department (CSFESD) Board meeting will be meeting on Thursday, February 28, 2019 at 6:00 PM.

Secretary Helwig reported that Kenneth Klingerman, Contract Management Engineer for PennDOT, contacted the Township to provide notice that on February 14, 2019 the Department will be opening bids on the milling and resurfacing of SR2007 (Fairground Road) from the intersection with Smoketown Road to SR 192 (Buffalo Road). Work will begin June 17, 2019 and end August 2, 2019 providing no weather interruptions. Construction will be done during the hours of 9:00 PM and 6:00 AM. Patrick Gillott, Department of the Auditor General, has requested information to begin the Township's January 1, 2015 to December 31, 2018 audit. Volunteer applications are needed to fill two vacancy positions for the remainder of the 2019 year. The open positions are Central Keystone Council of Governments and the Auditors Board. The advertisement for the Public Works Laborer position concluded on February 8, 2019; fifteen applications were received. The advertisement for the Township Manager position was posted online, in the Daily Item and on ZipRecruiter.com. To date ten resumes have been received. The Christmas Tree collection and clean up from the first major snowstorm in November has concluded. The Public Works Crew collected 459 trees compared to the 455 collected in 2018. They picked up 179 piles of storm damage branches compared to nothing in 2018. That is 399 cubic yards of material collected versus 42.49 cubic yards for 2018.

The new shade canopy in the park was bought at cost for \$15,000 from Playworld and installed by Willow Playworks at no charge. The only cost was \$140 for the rental of a lift to install the shade canopy. Vice Chairman Rowe reported that Buffalo Valley Regional Police Department (BVRPD) met on Wednesday, May 8th. Due to a difference in interpretation by the municipalities, the Borough has threatened to file a lawsuit against the Police Commission Department and the Township. The commission acted on Article XIV of the IGA, which states, that all differences arising out of interpretation of the agreement or between the municipalities shall be resolved by the Commission. The Commission passed a motion to affirm that municipalities may request Police Protection Units (PPU) in advanced of the fiscal year, as there is no outlined or referenced agreement terms that support an allocation on a percentage basis, only a requesting of PPUs by municipality.

Supervisor Schumacher reported that the next Central Susquehanna Fire and Emergency Services Department (CSFESD) Board meeting will be on Thursday, May 23, 2019 at 6:00 PM. The board will be discussing adjustments to streamline the agreement but retain the original intent of having the commission responsible for financial oversight. There has been discussion on the transfer of assets that was included in the IGA, which must have gotten there by copying another IGA. There are also some issues with the proposed transfer of assets. It seems pointless to make a transfer of assets and then include a statement that if the entity dissolves all assets will remain with the fire company, resulting in added fees for asset transfer and name change.
