The Township returned to in-person meetings at the Township building following the 8:00 AM, January 4, 2021 expiration of the statewide stay-at home order due to the COVID-19 pandemic surge. In addition, the Township continued use of a virtual meeting format at allow Township elected and appointed officials and members of the public to participate remotely in the regular monthly meeting of the Board of Supervisors.

Chairman Gray called the Board of Supervisors Meeting to order at 5:42 PM.

Those present: Chairman Charmaine Gray; Vice Chairman James Knight; Supervisor Matt Schumacher; Township Manager Stacey Kifolo; Solicitor Peter Matson; and Secretary/Treasurer Jolene Helwig.

Members of the public participating via the virtual meeting format: Debra Sulai (Lewisburg Borough); Eric Scicchitano (Daily Item); Georganna Kresl; Marilyn Murphy; Matt Farrand (Standard Journal); and Tina Prowant.

No members of the public were present at the Township building.

For the first segment of public comment, attendees were asked to limit comments on agenda topics.

Public Comments:

- Marilyn Murphy, EBT resident, asked the supervisors to verify Jack Malloy's status on the Buffalo Valley Regional Police Commission. Supervisors noted that he was appointed in 2019 to a two-year term, which expires December 2021.
- Tina Prowant, EBT resident, asked if Bucknell contributed to Animal Enforcement Officer.
 Township Manager replied they pay one-third of all cost.

Chairman Gray reported that she drove by the ice rink on way to township to check on the condition. Unfortunately, the warmer temperatures have not aided in the freezing of ice for skating.

Township Manager Kifolo reported that the official letter for the grant extension has been received from the State for the River Road Culvert project is in plan review. We are awaiting State approval for the project plans in order to issue notice to proceed to the contractor. Construction on ARLE & Green Light Go traffic signal grant projects is complete; all that remains is administrative work. There will be future action for the Board once a Highway Occupancy Permit (HOP) is issued by the State for an issue with the roadway resulting from the boring process at the intersection of US15/Moore & Smoketown. Kifolo stated she and Secretary, Jolene Helwig on December 16th with representatives from County Conservation, Northcentral Conservancy; and PA Fish and Boat Commission to discuss restoration of the tributary that runs through Fairground Road park, feeding the park pond and Limestone Run. The group will be conducting on-site visits, considering scheduling and project approval. The site is favorable because of the environmental impacts, high visibility, and connection to a section of Limestone Run that has been restored. Kifolo is hopeful that the project can be completed before construction is started on the Phase of the park restoration. Kifolo noted that one new hire started today; one position remains open with applicant still being considered.

Chairman Gray acknowledged that due to the early timing of the meeting, the Board had not yet received the Buffalo Valley Regional Police Department December 2020 report.

Chairman Gray acknowledged Board receipt of the Central Keystone Council of Governments (CKCOG) December 2020 report.

Motion by Chairman Gray and second by Vice Chairman Knight authorizing Solicitor Matson to proceed with the draft ordinance amendment for Flood Plain Regulations; and to advertise the same for a public hearing before the Board of Supervisors on February 8, 2021. All members consented to the payments requested in December. It was expressly noted that no payments would be made for any application(s) received or postmarked after December 31, 2020.

The Township noted that the ordinance allows for some burning provided it is contained in a metal or masonry barrel, pit or similar device no more than three feet square or three feet in diameter and located not less 25 from any structure nor less than 10 feet from a property line and recyclable materials are not to be burned.

Chairman Gray announced that an Executive Session was held on Monday, February 8, 2021 at 4:30 PM to discuss on-going litigation.

Chairman Gray called a public hearing to order at 5:37 PM, to consider and act upon an ordinance amending Chapter 27, Zoning, incorporating Part 10, Floodplain Regulations.

Public Comments for Floodplain Regulation Ordinance:

 Margaret Marr, EBT resident, asked the supervisors how can residents secure a copy of the language of the ordinance and proposed amendments. Township Manager answered that the ordinance was advertised in the paper; posted on the township website; available for review at the Township Office Building; and available at the Central Keystone Council of Government (CKCOG) office.

Chairman Gray closed the public hearing at 5:40 PM.

Motion by Supervisor Schumacher and seconded by Vice Chairman Knight to adopt Ordinance 396, amending Chapter 27 requiring all persons, partnerships, businesses, and corporations to obtain a permit for any construction or development: providing for the issuance of such permits; setting forth certain minimum requirement for new construction and development within areas of East Buffalo Township which are subject to flooding; and establishing penalties for any persons who fail, or refuse to comply with, the requirements or provisions of this ordinance. Public Comments:

- Brian Kerstetter, Kelly Township resident, introduced himself as a candidate for District Judge.
- Tina Prowant, EBT resident, asked if Brian Kerstetter was a Republican or Democrat.
 Brian Kerstetter replied that he is registered as a Republican but considers himself as a fiscal conservative and civil libertarian.
- Margaret Marr, EBT resident, asked the Supervisors why the Township Manager position was on the agenda. Chairman Gray stated that Township Manager Kifolo's contract is to

expire at the end of the year; therefore, now is the time to post a requisition for the position before the contract runs out.

Chairman Gray reported that the Saint Mary Street ice-skating rink is open to the public, weather permitting. BVRA's goal is to be open from 1:00 PM to 7:00 PM, Monday thru Thursday will be free skating. Gray stated that she spent 4 ½ hours shoveling snow off the ice so residents would be able to skate tonight. They had help from East Buffalo Township Public Works Crew for snow removal from the ice and the parking area. Gray noted that the BVRA Gala is schedule for March 6th at 7:00 PM. The gala is schedule for one hour via Zoom. Cost of registration for the event includes dinner provided by The Lewisburg Hotel and desserts from Bella's Bliss Bakery. There will be local entertainment and highlights of what is happening with BVRA programs. Please call the BVRA office or visit the BVRA website to purchase ticket(s) or to receive more information about the BVRA Gala.

Vice Chairman Knight reported that the Central Susquehanna Fire and Emergency Services Department (CSFESD) Board meeting scheduled for Thursday, January 28th at 6:00 PM was cancelled.

Supervisor Schumacher reported that the Buffalo Valley Reginal Police Commission (BVRPC) meeting will be Wednesday, February 10, 2021 at 5:00 PM. Kifolo noted that the link to virtual meeting was posted on the township website.

Township Manager Kifolo reported the 2020 Annual Report was sent to the supervisors for review. She stated that the bidding for the 2014 Kubota was placed on Municibid.com and posted in a local newspaper. Bids will be accepted through Municibid.com until 1:05 PM on April 5, 2021. The bid will be awarded on Monday, April 12, 2021 at 5:30 PM during the regularly scheduled meeting. Kifolo noted the State Department of Environmental Protection cancellation of the 2021 round of Section 902 Recycling Implementation Grants due to a lack of money in the Recycling Fund. The General Assemble redirected \$50 million from the fund to balance the final state budget that was adopted in November. This is the first time in the Recycling Program's 33-year history a round of grants has been canceled; but the fourth time the General Assembly has diverted money from the Recycling Fund to balance the State budget. The total diverted to date is \$84 million. Although we had no plan to enter an application for the round that was recently cancelled, the program has been beneficial to the Township in the past and always viewed as a funding potential to assist in keeping the recycling program cost for the taxpayers low. For example, the bulk of the cost to purchase the leaf vacuum was through the 902-grant program. As was the woodchipper, improvements for the recycling center, the launch of the bi-annual recycling newsletter, and other recycling items. Locals will be holding off on projects, making the next round even more competitive and possibly have less funding available. Recycling wasn't the only impact. Recreation/park funding is also impacted, as are local farmers. The General Assembly took a total of \$201,977,000 from environmental and energy funds to balance the FY 2021-22 state budget. Impacts include, but are not limited to, farmers being left without assistance to save their farms through the farmland preservation program; Brownfield industrials sites will not be cleaned up and made safe; and environmental education efforts will be set back; Clean energy projects will not move forward. Chairman Gray called a public hearing to order at 5:35 PM, to consider amendments to the following ordinances:

- Amending Chapter 20, Part 2 of Code of Ordinances, regulating the recycling of solid waste in East Buffalo and allowing the Board of Supervisors to implement program changes by ordinance or resolution.

For instance, residential areas along Route 15 would be limited to a 6 square feet sign under the current proposal and people traveling on Route 15 won't be able to see the sign. She is concerned that the size limitation is a violation of free speech rights. In her option she is still concerned about the brush and yard waste policies and thinks that the Township should have machines and abilities to do more, allow for drop-off and provide more collects per year. Chairman Gray stated that the township does pick up longer in the spring and fall because of the piles. She noted that there are other projects that the public works crew has to maintain for the township. She commented that she would like to see EBT have their own place for residents to take brush.
- Victor Udo, EBT resident, thanked the Board Members, Public Work Crew and the Planning Commission for their service they do for the township residents.
- Tina Prowant, EBT resident, thanked the township for their service and questioned the temporary sign ordinance.
- Harold Braasch, EBT resident, questioned the Supervisors about the plans for improving the stormwater and roadway of Oxford Drive.

Chairman Gray reported that the Buffalo Valley Regional Police Commission (BVRPC) meeting will be Wednesday, April 14, 2021 at 5:00 PM. Gray noted that the BVRA financials are still a concern. She stated BVRA plans to open the Saint Mary Street pool and plan to have summer camps.

Vice Chairman Knight reported that the Central Susquehanna Fire and Emergency Services Department (CSFESD) Board meeting scheduled for April was cancelled. He stated at the March 25th meeting that William Cameron Engine Company raised some concerns about their facility. The CSFES Board members asked that they make a list of their issues so they can be discussed at the May meeting.

Supervisor Schumacher stated owning property is not a privilege it's a right.

Township Manager Kifolo reported that the Other Post Retirement Benefits (OPEB) actuarial study as of January 1, 2020 was sent to the Board on March 22nd. The retirement "promise" was made in the 1980s and the Township had just been using "pay as you go". In 2013, the first actuarial study was completed, revealing a \$3.3M completely unfunded liability. In 2013, a subaccount was established in the Reserve account to begin building for investing (2013 = \$50k, 2014 = \$130k, 2015 = \$170k, and 2016 = \$50k). In 2016, the Township worked to get a reduction in the BVRPD health care premiums and secured a loan with a \$500k loan at an interest rate of 2.18% for five years. The \$900k was invested in September 2016. The balance on that account as of March 31st was \$1,636,837. Kifolo expressed that the OPEB account will be able to fund the expenses moving forward without putting a strain on the general fund budget or creating a need to increase taxes or foregoing other needed projects in order to meet this obligation. Kifolo stated that the resident text messaging service through TextMyGov is now operational. Residents can text "Hi" to 570-701-9007 to get alerts and additional information is available on the website. Kifolo noted pension proposals have been received and a review has begun. She announced that next week a meeting for the River Road Culvert project is planned. She received notification from PennDOT for seal coating projects on Old Schoolhouse Road - from Furnace Road to Smoketown Road and Salem Church Road - from Furnace Road to SR45. The roughly 4.5 miles of State roadways will be completed between July and September. She reminded everyone that it was Local Government week.

Secretary Helwig reported that the first round of brush and yard waste collection started today. She stated that she has been in contact with the auditors regarding the 2020 Municipal Annual Audit and Financial Reports deadline extension.

Chairman Gray announced that an Executive Session was held on Monday, May 10th at 4:45 PM to discuss legal matters. Executive Sessions were held on Wednesday, May 5th at 2:30 PM and 3:15 PM and Monday, May 10th at 4:30 PM for personnel matters.

Chairman Gray called a public hearing to order at 5:36 PM to consider and act upon an ordinance amending Chapter 27, Part 2, Section 201 and Part 5, Section 504 of the Code of Ordinances, regulating the utilization of non-permanent signs in East Buffalo Township.

Public Comments for regulating the utilization of non-permanent signs:

- Kathleen Evans, EBT resident, asked for clarification on whom determines the difference between political and general statement of personal philosophy, such as "Be Kind", "Black Live Matter" and "Vote". She asked if a sign with just a person name was allowed. She commented on the proposed twenty-five (25') feet between signs and the ten (10') feet from a boundary line and street right-of-way line. She also questioned the cost of the violation if the signs were not removed. Chairman Gray replied that a political sign is identified by a year but if it just had a name, it was not a political sign. Supervisor Schumacher stated that it was allowed since it didn't have a year. Supervisor Schumacher replied that the twenty-five (25') was for a competitor. They can't put a sign in front of yours to sign stack, but they still need to be ten (10') feet from boundary line and street right-of-way. Zoning Officer, Makenzie Stover stated common sense enforcement would be observed, working with the community and residents. She mentioned that enforcement could include a summary charge after a notification process and fines could be upward to \$500.00 plus court cost.
- Sue Ellen Feuerstein, EBT resident, asked if the supervisors were trying to make revisions that would make the ordinance more restrictive than the current ordinance. She questioned what constitutes a political sign and asked if the supervisor's reference to a year was written in the proposed ordinance. Vice Chairman Knight stated that in his opinion the proposed ordinance is less restrictive. Manager Kifolo noted that the intent was to have a sign ordinance that content neutral; instead of providing different regulations for different content-based signs, as the current ordinance provides. This action was also to bring the ordinance into compliance with the 2015 Supreme Court decision handed down in Reed v. Town of Gilbert. Makenzie Stover noted that the current ordinance has too much gray and the proposed ordinance is more enforceable.

- Joan Moreau, EBT resident, asked if this ordinance is taking care of current problems the sign placement distance from a street right-of-way, and the limit to the number of signs in a yard. Chairman Gray stated that it is simplifying and clarifying making things a lot clearer as to what signs fall into this non-permanent category.
- Margaret Marr, EBT resident, expressed her concerns and wants more transparency for the temporary sign ordinance amendment. She is concerned that the size limitation is a violation of free speech rights.
- Tina Prowant, EBT resident, concerned about the yard sales signs that the residents have on telephone poles. She questioned the supervisors if her political sign from last year could still be in her yard if she covered the year or stuck it in her house window. It was noted that the current ordinance does not permit the placement of signs on utility poles or street signs. Zoning Officer Stover noted that the ordinance would take effect five (5) days after adoption. The zoning officer will be the person to enforce the violation. Chairman Gray acknowledge that if the year was covered the sign could remain outside but if not, she was allowed to place inside her house in window.
- David Lightman, EBT resident, asked for clarification on Section 2, F Non-Permanent sign shall not be placed within twenty-five (25') feet of a sign previously placed.

Chairman Gray closed the public hearing at 6:39 PM.

Representatives Meghan Beck, President and Dr. Lenaire Ahlum, Executive Director from the Susquehanna Valley Community Education Project (SVCEP) made a presentation to the supervisors and public to gather support for a 10-year county commitment for the proposed regional community college that will partner with a university. The partner university will be announced on Friday May 14th. It was noted that the Central Workforce Investment Area is the only one in Pennsylvania that is not served by a community college. The SVCEP will serve Snyder, Union, Montour and Northumberland Counties with the main campus location in Northumberland County. The proposed college would offer certificates, industry certification and associate's degrees. SVCEP fields of study could arrange from agriculture, business, liberal arts, nursing, a variety of sciences and other skill trades.

Public Comments:

• Tina Prowant, EBT resident, questioned the cost to the township or to the residents and if a site was considered for the Lewisburg area. Dr. Ahlum responded that for ten (10) years it would be the same sponsorship amount for each county. Meghan Beck acknowledge that the location for the site would be based in an area where the population wouldn't have the advantage of going to a four-year college.

Township Manager Kifolo reported that she sent all the Act 101, Section 902 grant round 60 application to the Union County Recycling Coordinator. She stated she anticipates there should be an answer on grant funding in early 2022.

Secretary Helwig reported that East Buffalo Township has received the first half of the American Rescue Plan Act Funding. She stated she received notice today from the Union County Conservation District that the Fairground Road Park Project permits that were submitted in May have been approved.

The Board of Supervisors were informed that the River Road Culvert project took a major shift during construction when the structure under the roadway started to collapse. Plan B was quickly put into motion to obtain necessary materials and approvals. Instead of shoring up the culvert under the roadway and apply shotcrete, the roadway was opened for complete pipe replacement. The owner of the railroad estimates that the culvert was built in the 1883-1885 timeframe. What we do know is that the timing of the project pushed the actual paving beyond the grant deadline. Paving was not anticipated as a project need, only becoming necessary when the roadway needed to be opened. Because of the timing, the cost is not grant eligible and will be EBT's 100% responsibility. The cost is roughly \$12,000. The other changes significantly increased the overall cost, but actual totals have not been submitted by the engineer. The budget for 2021 Stormwater repairs is sufficient to cover even the increased cost or the Board of Supervisors could pull from Reserves. Pulling from the reserves is not necessary.

Chairman Char Gray started the meeting thanking Supervisor Schumacher for his service for the last 6 years; noting several of his accomplishments for the betterment of the township; in particular; initiating discussions and contractual agreements with police and fire departments to ensure better long-term contracts.

There were no public comments during the segment of the agenda limited to comments on agenda topics.

Chairman Gray reported that the Buffalo Valley Regional Police Commission (BVRPC) meeting was held on Wednesday December 9, 2021. The Buffalo Valley Regional Police Commission (BVRPC) November report will be posted on the website and Chairman Gray noted that call volume is back up to the pre-COVID numbers. Chairman Gray reported that the BVRPC Budget was passed and that they are looking to hire an additional Patrolman. Chairman Gray reported that BVRA held a highly successful Candle Fund Raiser, raising \$5,000. Gymnastic enrollment numbers are looking good, and BVRA got through the year without needing additional funds from the Township and the Borough. Chairman Gray reported that due to the warmer weather there were no current plans to fill the ice rink.

Vice Chairman Knight reported that the November meeting of the Central Susquehanna Fire and Emergency Services (CSFES) was cancelled but budget questions were answered by Chief Blount via email, and the budget will be voted on for approval this month. Vice Chairman Knight reported that he met with the Bucknell Golf Course Manager concerning a footpath along Stein Lane which resulted in lots of questions regarding safety and liability. Vice Chairman Knight recommended that the next step be putting together a list of ideas, plans, etc. and scheduling a meeting, including someone from Solicitor Matson's office, to discuss.

Supervisor Schumacher thanked everyone who helped him in his role as a Township Supervisor for the past 6 years stating that it was a learning experience, and he has enjoyed his time as a supervisor.

Township Manager Helwig reported that the 2020 Audit has been finalized and has been posted on the Township bulletin board and Website. SEDA COG is working on updating the township website and hopefully has the new layout design done by the end of the year. Township Manager Helwig reported that newly elected County Tax Collector Dan Greene has expressed interest in utilizing one of the office suites at the township building as his tax collection site. Township Manager Helwig recommended having a one-year agreement drawn up at no charge to him based on his needs and township guidelines and see how it works out. After the year is up the agreement can be re-evaluated. Township Manager Helwig questioned whether the on-line meeting participation would continue into 2022 and it was agreed that it would. She expressed concerns that different or additional equipment may be needed for a smoother process. The final round of leaf collection was in process and once complete the crews would move on to cutting and grading banks and ditches and possibly tree trimming as the weather allowed. Spring brush pickup is scheduled to start in April of 2022.

Chairman Gray acknowledged Board receipt of the November 2021 Buffalo Valley Regional Police Department (BVRPD) reports.

Chairman Gray acknowledged Board receipt of the Central Keystone Council of Governments (CKCOG) November 2021 report.

Discussion on amending the existing solar ordinance to include the recycling of solar panels once they are decommissioned. It was agreed to keep recycling solar panels separate from the existing zoning ordinance already in place for solar panels. Possibly set a maximum number of panels a residential property could

have before they would be subject to the recycling requirements, instead focusing on the larger "fields" of panels. Solicitor Matson will draft an ordinance to present at the next scheduled meeting for further discussion.

For the Good of the Order: Chairman Knight thanked Supervisor Schumacher for his service to the township the last six (6) years.

For the second segment of public comment, the attendees were welcomed to comment on matters discussed during the meeting or topics not appearing on the agenda.

Public Comments:

- Tina Prowant, EBT resident, thanked Supervisor Schumacher for all his work for the residents over the last six (6) years. She asked about the status of the letter being sent to residents who will be affected by the proposed streetlight on Jefferson Avenue between 16th & 17th streets. Township Manager Helwig stated that the letter should be out by the end of the week.
- Matt Farrand; Standard Journal; asked for clarification on the assessment of Fairfield Inn and the
 tax revenue it will produce. Chairman Gray responded that Union County Assessment Office,
 which was meeting this week, would have an assessment on the Fairfield Inn and believes it will
 be about or at least \$25,000. Matt asked for a review of the tax mills and if money was pulled from
 the Reserve Fund. Chairman Gray relayed the adopted tax mills and stated no money was pulled
 from the Reserve Fund.
