ORDINANCE

AN ORDINANCE OF EAST BUFFALO TOWNSHIP, UNION COUNTY, PENNSYLVANIA, AMENDING CHAPTER 1, PART 1, SECTION 101, OF THE CODE OF ORDINANCES OF EAST BUFFALO TOWNSHIP REGARDING TOWNSHIP SUPERVISORS' COMPENSATION.

BE IT ENACTED AND ORDAINED BY THE BOARD OF SUPERVISORS OF EAST BUFFALO TOWNSHIP, UNION COUNTY, PENNSYLVANIA AND IT IS HEREBY ENACTED AND ORDAINED BY AUTHORITY OF THE SAME AS FOLLOWS:

SECTION 1: Chapter 1, Part 1, Section 102- Compensation of Township Supervisors. Each Supervisor of East Buffalo Township, Union County, Pennsylvania elected or appointed to office, shall receive compensation as a Supervisor in an amount determined by the Board of Supervisors by Resolution in an annual amount not to exceed the maximum amount permitted by law based upon the population of East Buffalo Township, Union County, Pennsylvania as determined in the then most recent U.S. Official Census. Said Compensation shall be paid monthly.

SECTION 2: ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT HERewith ARE HEREBY REPEALED.

SECTION 3: THIS ORDINANCE SHALL BE EFFECTIVE FIVE (5) DAYS AFTER ADOPTION.
