# EAST BUFFALO TOWNSHIP, UNION COUNTY, PENNSYLVAINA ORDINANCE NO

AN ORDINANCE OF EAST BUFFALO TOWNSHIP, UNION COUNTY, PENNSYLVANIA BY THE ISSUE OF A GENERAL OBLIGATION NOTE IN THE AMOUNT OF \$765,000.00 FOR CONSTRUCTION OF TURTLE CREEK BRIDGE FIXING THE FORM, NUMBER, DATE, INTEREST AND MATURITY THEREOF; MAKING A COVENANT FOR THE PAYMENT OF THE DEBT SERVICE ON THE NOTES; PROVIDING FOR THE FILING OF THE REQUIRED DOCUMENTS PROVIDING FOR THE APPOINTMENT OF A SINKING FUND DEPOSITORY FOR THE NOTE; AND AUTHORIZING EXECUTION, SALE AND DELIVERY THEREOF.

WHEREAS, it is necessary that the indebtedness of the Township of East Buffalo,
Union County, Pennsylvania be increased for the following purpose: Turtle Creek Road Bridge
Replacement; and

WHEREAS, the East Buffalo Township has received preliminary realistic cost estimates from professional consultants indicating the sum of \$765,000.00 will be needed to complete the project; and

WHEREAS, the proposed increase of debt, together with its nonelectoral indebtedness and its lease rental indebtedness presently outstanding, will not cause the limitations of the East Buffalo Township debt incurring power, pursuant to constitutional and statutory authority to be exceeded:

**NOW THEREFORE, BE IT ORDAINED AND ENACTED** by the Township of East Buffalo, Union County, Pennsylvania, and it is hereby ordained and enacted by the authority of same as follows:

**SECTION 1:** That the aggregate principle amount of the Note of the Township of East Buffalo, Union County, Pennsylvania, proposed to be issued is \$765,000.00, same to be issued for the foregoing purposes, the same to be incurred as nonelectoral debt.

**SECTION 2:** The period of useful life of the improvements for which this obligation is to be issued is estimated to be in excess of 50 years.

**SECTION 3:** Said indebtedness shall be evidenced by one general obligation Note, in fully registered form, in the sum of \$765,000.00 dated and bearing interest from the earliest possible issue of said Note under the statutory time requirements as set forth in the Act of general Assembly of the Commonwealth of Pennsylvania approved by the 28<sup>th</sup> day of April, 1978, being Act 52 of 1978 Session and known to the Local Government Unit Debt Act, at the rate of interest of four and one quarter percent (4.25%) per annum, payable on the unpaid balance of said Note on five years from the date of the Note during the term of said Note, together with interest on overdue principal, and to the extent permitted by law, on overdue interest, at the rate of 4.25% per annum (computed on the basis of 365 days to the year) until paid, which Note shall mature in installments on the quarterly anniversary date of the Note as follows:

East Buffalo Township reserves the right to anticipate any or all installments of principal or any payment of interest at any time prior to the respective payments dates thereof, without notice or penalty.

The principal and interest of said Note shall be payable at the office of the sinking fund depository selected for the Note as hereinafter provided.

**SECTION 4:** The said Note is hereby declared to be a general obligation of the Township of East Buffalo, Union County, Pennsylvania. East Buffalo Township hereby covenants that it shall include the amount of debt service on the Note for each fiscal year in which sums are payable in its budget for that year; shall appropriate such amounts to the payment of such debt services; and shall duly and punctually pay or cause to be paid the principal of the Note and the interest thereon at the dates and places and in the manner stated in the Note according to the true intent and meaning thereof, and for such proper budgeting, appropriation, and payment, the full faith, credit and taxing power of the Township of East Buffalo us here by irrevocably pledged.

The amounts which East Buffalo Township hereby convents to pay in each of the following fiscal years on the basis of an interest rate of 4.25% are as follows:

**SECTION 5:** The form of said Note shall be substantially as set forth in the attached Exhibit N.

**SECTION 6:** The said Note shall be executed in the name and under the corporate seal of East Buffalo Township by the Chairman of the Board of Supervisors and Township Manager and attested to by the Secretary. The Treasurer is herby authorized and directed to deliver said Note to the purchaser, and receive payment therefor on behalf of East Buffalo Township. The

Chairman of the Board of Supervisors and Secretary of East Buffalo Township are authorized and directed to prepare, verify and file the debt statement required by Section 8110 of the Act and to take other necessary action, including, if necessary or desirable, any statements required to qualify any portion of debt from the appropriate debt limit as self-liquidating or subsidized debt.

SECTION 7: Susquehanna Community Bank is hereby designated as the Sinking Fund Depository for the obligation herein authorized, and there is hereby created and established a Sinking Fund to be known as "Sinking Fund 2025 General Obligation Note" for the payment of the principal and interest thereon which shall be deposited into the Sinking Fund no later than the date upon which the same becomes due and payable. The Treasurer shall deposit into the Sinking Fund, which shall be maintained until such obligation is paid in full, sufficient amounts for payment of principal and interest on the obligation no later than the dates upon which such payments shall become due. The Sinking Fund Depository shall, as and when said payments are due, without further action by East Buffalo Township, withdraw available monies in the Sinking Fund and apply said monies to payment of principal and interest on the obligation.

**SECTION 8:** The Chairman of the Board of Supervisors and Township Manager of Township of East Buffalo, Union County, are herby authorized to contract with Susquehanna Community Bank for its services as Sinking Fund Depository for the Note and paying agent for the same.

SECTION 9: In compliance with Section 8161 of the Act, the members of the governing body have determined that a private sale by negotiation rather than public sale is in the best financial interest of East Buffalo Township. Therefore the general obligation Note in the amount of \$765,000.00, herein authorized to be issued and sold hereby awarded and sold to Pennsylvania Infrastructure Bank in accordance with its proposal to purchase the said Note at par; provided the said Note is dated the delivery thereof to the Pennsylvania Infrastructure Bank and is in the form set forth in this Ordinance as Exhibit N; and further provided that the proceedings have been approved by the Department of Community and Economic Development if such approval is required under the provisions of the Act.

SECTION 10: The action of the proper officers and the advertising of a summary of this Ordinance as required by law in the Milton Standard Journal, a newspaper of general circulation, is ratified and confirmed. The advertisement in said paper of the enactment of the Ordinance is hereby directed within fifteen (15) days following the day of final enactment.

**SECTION 11:** All Ordinances or parts of Ordinances not in accord with this Ordinance are hereby repealed insofar as they conflict herewith.
