**EAST BUFFALO TOWNSHIP**

**ORDINANCE NO \_\_\_\_\_**

**AN ORDINANCE OF EAST BUFFALO TOWNSHIP, UNION COUNTY, PENNSYLVANIA, AMENDING CHAPTER 2, PART 1 AND PART 3 OF THE CODE OF ORDINANCES OF EAST BUFFALO TOWNSHIP REGARDING CATS.**

**BE IT ENACTED AND ORDAINED BY THE BOARD OF SUPERVISORS OF EAST BUFFALO TOWNSHIP, UNION COUNTY, PENNSYLVANIA AND IT IS HEREBY ENACTED AND ORDAINED BY AUTHORITY OF THE SAME AS FOLLOWS:**

**SECTION 1:** Chapter 2, Part 1, Section 105 of The Code of Ordinances of East Buffalo Township, Union County, Pennsylvania, is amended by adding the following:

**(c).** This prohibition shall not be applicable to a participant of a TNR program as provided in Section 304 of this Chapter or a registered caregiver of a TNR program, as provided in Section 306 of this Chapter.

**SECTION :** Chapter 2, Part 3, Section 301 of The Code of Ordinances of East Buffalo Township, Union County, Pennsylvania, is amended by adding the following:

**4.** This Section shall not apply to the Agricultural Preservation zoning district, the Agricultural Residential zoning district and the Woodland Preservation zoning district.

**SECTION 3: ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT HERewith ARE HEREBY REPEALED.**

**SECTION 4: THIS ORDINANCE SHALL BE EFFECTIVE FIVE (5) DAYS AFTER ADOPTION.**


