AN ORDINANCE OF EAST BUFFALO TOWNSHIP, UNION COUNTY, PENNSYLVANIA, AMENDING CHAPTER 2 OF THE CODE OF ORDINANCES OF EAST BUFFALO TOWNSHIP REGARDING PROHIBITIONS AGAINST ANIMALS RUNNING AT LARGE IN EAST BUFFALO TOWNSHIP, UNION COUNTY, PENNSYLVANIA.

BE IT ENACTED AND ORDAINED BY THE BOARD OF SUPERVISORS OF EAST BUFFALO TOWNSHIP, UNION COUNTY, PENNSYLVANIA AND IT IS HEREBY ENACTED AND ORDAINED BY AUTHORITY OF THE SAME AS FOLLOWS:

SECTION 1: Chapter 2, Part 2, Section 204 of the Code of Ordinances of East Buffalo Township, Union County, Pennsylvania, is hereby amended by adding as follows:

§204. Prohibitions. The following shall be prohibited unless specifically permitted by other provisions of this Chapter:

- (1) Running At Large. As provided in Section 105 of this Chapter, tt shall be unlawful for any person(s) to permit any dog, owned, kept, maintained, or in the custody or control of such person(s) to run at large in East Buffalo Township.
 - (a) This prohibition shall not be applicable in the Agricultural-Preservation, Agricultural-Residential and Woodland-Preservation Zoning Districts.
 - (b) Dogs may be permitted to run at large on lands owned by the Township in areas designated by the Township from time to time by resolution.

SECTION 2: Chapter 2, Part 3, Section 307 of the Code of Ordinances of East Buffalo Township, Union County, Pennsylvania, is hereby amended by adding as follows:

- §307. Prohibitions. The following shall be prohibited unless specifically permitted by other provisions of this Chapter:
- (1) <u>Running At Large.</u> As provided in Section 105 of this Chapter, tt shall be unlawful for any person(s) to permit any cat, owned, kept, maintained, or in the custody or control of such person(s) to run at large in East Buffalo Township.
 - (a) This prohibition shall not be applicable in the Agricultural-Preservation, Agricultural-Residential and Woodland-Preservation Zoning Districts.
 - (b) Cats may be permitted to run at large on lands owned by the Township in areas designated by the Township from time to time by resolution.
 - (c) This prohibition shall not be applicable to a participant of a TNR program as provided in Section 304 of this Part or a registered caregiver of a TNR program as provided in Section 306 of this Part.
- **SECTION 3:** Chapter 2, Part 4, Section 411 of the Code of Ordinances of East Buffalo Township, Union County, Pennsylvania, is hereby amended by adding as follows:
- §411. Prohibitions. The following shall be prohibited unless specifically permitted by other provisions of this Chapter:
- (1) <u>Running At Large.</u> As provided in Section 105 of this Chapter, it shall be unlawful for any person(s) to permit any chicken, owned, kept, maintained, or in the custody or control of such person(s) to run at large in East Buffalo Township.
 - (a) This prohibition shall not be applicable in the Agricultural-Preservation, Agricultural-Residential and Woodland-Preservation Zoning Districts.
 - (b) Chickens may be permitted to run at large on lands owned by the Township in areas designated by the Township from time to time by resolution.

SECTION 4: ALL ORDINANCES OR PART OF ORDINANCES INCONSISTENT HEREWITH ARE HEREBY REPEALED.
